WE OFFER A FULL RANGE OF AQUATIC THERAPY AND REHABILITATION PROGRAMMING FOR THE MANY SENIORS THAT HAVE RETIRED TO THE AREA. THE Y'S CHILD ENRICHMENT PROGRAM HAS WEEKLY SWIM LESSONS BUILT INTO ITS CURRICULUM. OUR DOLPHIN SWIM TEAM PROVIDES OVER 40 KIDS A CHANCE TO PROMOTE TEAMWORK, INTERACTION, AND DEVELOPMENT OF SOCIAL AND PHYSICAL SKILLS. 


